Election of Council President Pro-Temp for 2024

PERU UTILITIES SERVICE BOARD RESOLUTION 15-23

SALARIES FOR ELECTED OFFICIALS AND UTILITY SERVICE BOARD MEMBERS

Whereas, the Peru Utility Service Board has the responsibility for establishing the compensation of its employees and for recommending the annual salary to be paid from Utility funds to the Mayor, Clerk-Treasurer, and Utility Service Board Members.

Now, Therefore, be it resolved that the following salaries be established for the City of Peru Common Council for their consideration and approval for 2024: Mayor \$28,281.47 and Clerk Treasurer \$18,710.89 and Utility Service Board Members \$6,108.19.

Clerk Treasurer explained to the council that the Utilities contributes funds to help pay the salaries of the mayor and clerk treasurer. This is a payment in lieu of taxes and they have been doing this for many years. The city owns the utilities and rather than charge them taxes, they pay portions of these wages as compensation for work performed on behalf of the utilities.

Councilperson Huber moved, seconded by Councilperson Stevenson, to adopt Resolution 15-23. Motion passed with a vote of 7 Ayes, 0 Nays

Police Chief Feller presented Michael Vinopal as the new Assistant Chief. He read a list of Officer Vinopal's ranks and accomplishments. Clerk Treasurer Krauskopf then administered the Oath of Office to Assistant Chief Vinopal.

Fire Chief Daine then presented the firefighters who had assumed a new rank as of January1, 2024. The new Assistant Chiefs are Hayden Sturch and Jeromy Hileman, joining Mark Bowyer Assistant Chief. Clerk Treasurer Krauskopf then administered the Oath of Office to all the Assistant Chiefs.

Mayor Sturch presented Bruce Carson as his nominee for the position of Building Commissioner. Councilperson Fisher moved, seconded by Councilperson Anderson, to approve the hiring of Bruce Carson as Building Commissioner. Motion carried with a vote of 7 Ayes, 0 Nays
