Murphy: Stated she had attended the Park Board meeting

Fisher: He attended the Peru Utilities meeting they discussed wastewater upgrades. and the MCEDA meeting on 3/13, where the Interlocal Stellar Program was discussed. He attended the Recycling District meeting, and they are adding additional recycling bins due to the drop off location behind Hardees being closed. He also attended the Rediscover Downtown and Central Dispatch meetings.

Sahaidachny: Reported on the last Board of Works Arts Festival will be held May 11th. County Council on 3/19 discussed Immunization Grant and possibility of hiring full time nurse.

Huber: He reported Animal Control board discussed currently having 7 dogs in house, ventilation system, along with the shade at the dog park being installed and making sure it is placed correctly and secured. Sanitation will begin their downtown clean this month. Airport will be holding their open house on September 7.

Stevenson: He reported that MCEDA is set to begin the Forest Street project that has been funded by READI Grant. Work is to start approximately April 1st and end approximately August 31st.

CITY OF PERU COMMON COUNCIL RESOLUTION # 9 - 2024

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF PERU APPROVING THE INTERLOCAL PARTNERSHIP FOR THE INDIANA STELLAR PATHWAYS PROGRAM

In accordance with Indiana Code 36-1-7-1 et. Seq., the City of Peru, the town of Bunker Hill, the town of Converse, Miami County, and the Miami County Economic Development Authority all of which entities are located in Miami County, Indiana, enter into this Interlocal Governmental Agreement (the "Agreement") and agree as follows:

WHEREAS, The Indiana Stellar Pathways program is a multi-agency partnership designed to recognize smaller communities and regions to assist in community and economic development;

WHEREAS, through annual designation, the Stellar Pathways program provides resources for transformative quality of place, community and regional improvements by fostering regional collaborative behaviors and investments:

WHEREAS, the Stellar Pathways Designees have the opportunity to apply for funding and support from various Indiana agencies which funding includes, but is not limited to those agencies listed on "Attachment 1";

WHEREAS, the City of Peru, the town of Bunker Hill, the town of Converse, Miami County, and the Miami County Economic Development Authority (hereinafter referred to individually as a "regional partner" and collectively as "the Regional Team") have come together as a region to apply for the Stellar Pathways program.

WHEREAS, the implementation of a successful Stellar Pathways program requires other resources including the sustained commitment of a staff and of the governing bodies of the Regional Team; and

WHEREAS, the Regional Team members now desire to enter into this Interlocal Governmental Agreement ("Agreement") which will ensure that the sustained commitment exists to provide the support and structure necessary to successfully apply for and implement the Stellar Pathways program.

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF PERU, INDIANA, That:

- 1. The Common Council has partnered with the Miami County Economic Development Authority for participation in the Stellar Pathways program creating Accelerate Miami County.
 - 2. Accelerate Miami County has attended a mandatory Stellar Pathways program workshop.
- 3. If chosen as a Stellar Pathway participant, develop a Strategic Investment Plan with a qualified consulting team.
 - 4. Present the Region's Strategic Investment Plan to the Stellar Pathways Committee.
- 5. If chosen as a Stellar Pathways Designee, implement Strategic Investment Plan projects and programs with the use of set-aside funding, bonus points, and annual funding rounds within five years of designation.
- 6. Attend quarterly meetings during those -years to measure project completion, success, and obstacles.

Councilperson Huber moved, seconded by Councilperson Stevenson, to consider Resolution 9-2024. Motion carried by a vote of 5 Ayes, 0 Nays.

Jim Tidd from MCEDA explained that the Stellar Pathways Program has taken a different approach since Covid, it is now a regional approach. That Miami County along with Peru, Bunker Hill and Converse would enter into this Local Governmental Agreement. That the first phase of the grant is the Resolution supporting the agreement along with a letter of intent due by May 1st. The finalist will be announced by June 1st and with that is a \$50,000 grant for strategic planning. There will be 2 winners of the 9-million-dollar grant, and they will be announced in January. Jim stated that this grant will be very competitive.

Councilperson Huber moved, seconded by Councilperson Stevenson, to approve Resolution 9-2024. Motion carried with a vote of 5 Ayes, 0 Nays.
