5. If multiple qualified bids for the same property are received, a subsequent round of bidding will take place. A letter will be mailed to those bidders indicating the highest original bid amount with an invitation to bid one final time.
6. Once a bid is accepted and awarded, the purchaser will have ten (10) business days to pay the bid amount in its entirety, for the property. Payment shall be made payable to "City of Peru" and taken or sent to City of Peru, Clerk's Office, 35 S Broadway, Peru, Indiana.
