#### **OLD BUSINESS:**

Request by Lita Harris to place a stop sign at the intersection of Monroe St and Wayne St. There is a stop sign on Wayne for traffic N/S, but there is not one on Monroe for E/W. Lita had an accident at that location and several others have stated they have almost had one as well. Mayor Struch stated that to place a stop sign in this location a traffic study would need to be done, there would need to be more than 300 vehicles per hour and 5 or more accidents there in the last 5 years. With no one present to discuss, Mayor Sturch made a motion to deny this request, seconded by Board Member Carson.

A request from the Sanitation Department to switch vendor for garbage truck ordered October 2023 from Best Equipment \$ 236,629.00 to Pyramid Equipment \$220,040.00. Brian stated that the truck was ordered from Best Equipment in October of 2023, they received the chassis in May of 2024, with now an expected delivery date of May 2025. Brian stated that the 2 trucks that were ordered late 2024 from Pyramid, one has been received, and the other is slated for May 2025. If we were to cancel with Best Equipment, they would have the 3<sup>rd</sup> truck available in May as well. A motion was made by Mayor Sturch, seconded by Board Member Carson to approve canceling Best Equipment's order and purchasing from Pyramid Equipment.
